The Department of the Environment for Northern Ireland (in this Order referred to as "the Department") in exercise of the powers conferred by section 1 of the Housing (No. 2) Act (Northern Ireland) 1946(a) and now vested in it(b) and of every other power enabling it in that behalf, with the approval of the Department of Finance(c), hereby makes the following Order:-

1. This Order may be cited as the Housing Subsidy (Variation) Order (Northern Ireland) 1977 and shall be construed as one with the Housing Subsidy Order (Northern Ireland) 1976(d) and shall come into operation on 16th March 1977.

2. In its application to a housing scheme in respect of which the tender has been submitted for approval to the Department by the Northern Ireland Housing Executive(e) after 15th March 1977 the Housing Subsidy Order (Northern Ireland) 1976 shall be amended by substituting for the Schedule therein the Schedule to this Order.
