The Department of Agriculture in exercise of the powers conferred on it by Section 1 of the Agriculture (Temporary Assistance) Act (Northern Ireland) 1954(a) as amended by the Agriculture (Temporary Assistance) (Amendment) Act (Northern Ireland) 1957(b) and now vested in it(c) and of every other power enabling it in that behalf and with the approval of the Department of Finance(d) hereby makes the following Scheme:

Citation and commencement

1. This Scheme may be cited as the Pigs (Feed Price Allowance) (Amendment) Scheme (Northern Ireland) 1977 and shall come into operation on 2nd May 1977.

Amendment of Scheme

2. The Pigs (Feed Price Allowance) Scheme (Northern Ireland) 1972(e) as amended(f) is hereby further amended as follows:

In Article 4 from "expended under this Scheme" to "31st March 1977" there shall be substituted "expended under this Scheme, the Eggs (Feed Price Allowance) Scheme (Northern Ireland) 1973 as amended(g) and the Poultry (Feed Price Allowance) Scheme (Northern Ireland) 1971 as amended(h) shall not in total exceed £6 million in respect of the period from 2nd February 1976 until 31st March 1978".
