The Secretary of State(a) in pursuance of section 10 of the Police Act (Northern Ireland) 1970(b), read with section 18 of the Administrative and Financial Provisions Act (Northern Ireland) 1962(c), and after consulting the Police Council for the United Kingdom and, in accordance with section 34(2) of the said Act of 1970, the Police Authority for Northern Ireland and the Police Association for Northern Ireland, hereby, with the concurrence of the Minister for the Civil Service(d), makes the following regulations:

Citation, commencement and effect

1.--(1) These regulations may be cited as the Police Cadets (Amendment) Regulations (Northern Ireland) 1977.

(2) These regulations shall come into operation on 16th May 1977 and shall have effect-

(a) for the purposes of regulation 3, as from 1st April 1976;

(b) for the purposes of regulation 4, as from 1st July 1975.

Interpretation

2. In these regulations a reference to the principal regulations is a reference to the Police Cadets Regulations (Northern Ireland) 1970(e).

Footwear allowance

3. In regulation 16(1A) of the principal regulations (footwear allowance) for the sum "£0.29" there shall be substituted the sum "£0.35".

London Supplement

4. In paragraph 2 of Schedule 1 to the principal regulations (supplement payable to a cadet attached to the Metropolitan Police Force) for the rate "£165" there shall be substituted the rate "£191".

EXPLANATORY NOTE

(This note is not part of the regulations but is intended to indicate their general purport.)

These regulations amend the Police Cadets Regulations (Northern Ireland) 1970 with effect from the dates mentioned below.

Regulation 3, with effect from 1st April 1976, increases the amount of footwear allowance from $\pounds 0.29$ to $\pounds 0.35$ a week.

Regulation 4, with effect from 1st July 1975, increases by £26 the supplement payable to a police cadet attached to the Metropolitan Police Force.

Retrospection is authorised by section 18 of the Administrative and Financial Provisions Act (Northern Ireland) 1962.
