## ULSTER SAVINGS CERTIFICATES

## Ulster Savings Certificates (Amendment) Regulations 1978

Made . . . . . 26th May 1978

Coming into operation . . . . . 17th June 1978

The Department(a) of Finance in exercise of the powers conferred upon it by Sections 15(1) and 16(1) of the Exchequer and Financial Provisions Act (Northern Ireland) 1950(b) as amended by Section 2 of the Administrative and Financial Provisions Act (Northern Ireland) 1962(c) and of all other powers enabling it in that behalf hereby makes the following regulations:

1.—(1) These regulations may be cited as the Ulster Savings Certificates (Amendment) Regulations 1978 and shall be construed as one with the Ulster Savings Certificates Regulations 1962 to 1977(d) and those regulations and these regulations may be cited together as the Ulster Savings Certificates Regulations 1962 to 1978.

(2) These regulations except regulation 3 shall come into operation on 17th June 1978 and regulation 3 shall come into operation on 1st July 1978.

2.—(1) The currency of any Ulster Savings Certificate of an Issue described in the Schedule shall be prolonged to a date 6 years after the date of purchase of that Certificate in accordance with the terms of the Schedule.

(2) The Schedule shall have effect so as to ensure that the currency of Ulster Savings Certificates which have not been repaid and are of an Issue specified in column 1 (of which particulars are given in columns 2 and 3) shall be prolonged from the date first specified in column 4 until the date secondly so specified and when a Certificate is repaid the amounts specified for that Certificate in column 5 shall be payable by way of interest in addition to any other amount payable in respect of the Certificate.

3. Schedule 3 to the Ulster Savings Certificates Regulations 1962(e) (which Schedule prescribes the maximum number of certificates which may be held), shall be further amended by substituting for paragraphs (i) (j) and (k) the following paragraphs:—

“(i) Three thousand, in the case of certificates issued between 17th June 1974 and 12th December 1976 and on or after 1st April 1977 (known as the Fourteenth Issue); and

- (j) Fifty, in the case of certificates issued on or after 2nd June 1975 under the name of Ulster Savings Certificates Index Linked Retirement Issue; and
- (k) Three hundred, in the case of certificates issued between 12th December 1976 and 31st March 1977 (known as the Sixteenth Issue)."

4. The Ulster Savings Certificates Regulations 1962 to 1977 shall have effect subject to regulations 2 and 3.

## EXPLANATORY NOTE

*(This note is not part of the regulations but is intended to indicate their general purport.)*

These regulations extend the currency of Ulster Savings Certificates of the Fourteenth Issue for a further two years i.e. from four years to six years with interest for each unit Certificate at the rate of nine pence for the fifth year and at the rate of twelve pence for the sixth year. They also increase the maximum holding which a person may have in this Issue to 3000 units (£3,000). Certificates of this Issue were introduced on 17th June 1974 by regulations contained in S.R. 1974 No. 55 with an initial life of four years and a permitted maximum holding of 1000 units (£1,000).
