# Building Societies (Fees) (Amendment) Regulations (Northern Ireland) 1978

Made 2nd February 1978 1st April 1978 Coming into operation

The Registrar, in exercise of the powers conferred upon him by section 123(1) of the Building Societies Act (Northern Ireland) 1967(a), and of every other power enabling him in that behalf, and with the consent of the Department(b) of Commerce, hereby makes the following regulations:

#### Citation and commencement

1. These regulations may be cited as the Building Societies (Fees) (Amendment) Regulations (Northern Ireland) 1978 and shall come into operation on 1st April 1978.

### Revocation

2. The Building Societies (Fees) (Amendment) Regulations (Northern Ireland) 1976(c) are hereby revoked.

# Amendment of fees

3. For Schedule 2 to the Building Societies (Forms and Fees) Regulations (Northern Ireland) 1968(d) (as substituted by the Building Societies (Fees) (Amendment) Regulations (Northern Ireland) 1976) there shall be substituted the following Schedule:

## EXPLANATORY NOTE

(This note is not part of the regulations but is intended to indicate their general purport.)

These regulations provide for a general increase in the level of the fees payable in connection with the exercise by the Registrar of his functions under the Building Societies Act (Northern Ireland) 1967, and for the inspection and the furnishing of copies or extracts of documents. The fees payable for reference of a dispute to the Registrar and for his award remain unchanged. These regulations supersede the Building Societies (Fees) (Amendment) Regulations (Northern Ireland) 1976.
