WORKMEN'S COMPENSATION**The Workmen's Compensation (Supplementation) (Amendment) Regulations (Northern Ireland) 1978***Made* 13th October 1978*Coming into operation* 15th November 1978

The Department of Health and Social Services for Northern Ireland, in exercise of the powers conferred on it by sections 2 and 4(1) of the Industrial Injuries and Diseases (Northern Ireland Old Cases) Act 1975(a), and of all other powers enabling it in that behalf, and with the consent of the Department of Finance for Northern Ireland, hereby makes, in consequence of the Social Security Benefits Up-rating Order (Northern Ireland) 1978(b), the following regulations:

Citation, commencement and interpretation

1.—(1) These regulations, which may be cited as the Workmen's Compensation (Supplementation) (Amendment) Regulations (Northern Ireland) 1978, shall be read as one with the Workmen's Compensation (Supplementation) Regulations (Northern Ireland) 1966(c) (hereinafter referred to as "the principal regulations"), as amended(d), and shall come into operation on 15th November 1978.

(2) In these regulations—

"the operative date" means 15th November 1978.

(3) The Interpretation Act (Northern Ireland) 1954(e) shall apply to these regulations as it applies to a Measure of the Northern Ireland Assembly.

Amendment of regulation 5 of the principal regulations

2. Paragraph (1A) of regulation 5 of the principal regulations (lesser incapacity allowance) shall be amended by substituting for the date "16th November 1977" the date "15th November 1978".

Substitution of Schedule 1 to the principal regulations

3. For Schedule 1 to the principal regulations (table of rates of lesser incapacity allowance for beneficiaries to whom regulation 5(1A) applies and table of loss of earnings and corresponding rate of lesser incapacity allowance) there shall be substituted the Schedule set out in the Schedule to these regulations.

Transitional provision relating to amount of allowance payable

4.—(1) Paragraph (2) shall apply to a beneficiary who was, before the operative date, in receipt of lesser incapacity allowance but in respect of whom the final calculation of earnings required by regulation 7(1A) of the principal regulations had not been made by that date.

(2) In such a case as is referred to in paragraph (1) the beneficiary shall be treated as entitled from the operative date to an allowance at the rate to which he would have been entitled had the final calculation been made before the operative date.

Transitional provision relating to claims not made before the operative date

5.—(1) The provisions of paragraph (2) shall apply to a person whose claim for lesser incapacity allowance was not made before the operative date and who is awarded such an allowance for a period after the operative date at one of the rates shown in the second column of Part II of Schedule 1 to the principal regulations.

(2) Any lesser incapacity allowance which is found to be payable to such a person as aforesaid in respect of a period before the operative date shall—

(a) in so far as it relates to the period from and including 16th November 1977 to 14th November 1978, be paid at the rate shown in the first column of Part I of Schedule 1 to the principal regulations which corresponds to the rate awarded to him for the period after the operative date; and

(b) in so far as it relates to a period before 16th November 1977, be paid at the rate or rates then in force which corresponds or correspond to the rate awarded to him for the period after the operative date.

Transitional provision relating to claims made but not determined before the operative date

6.—(1) The provision of paragraph (2) shall apply to a person whose claim for lesser incapacity allowance was made but not determined before the operative date.

(2) Any lesser incapacity allowance which is found to be payable to such a person as aforesaid in respect of a period before the operative date shall be paid at the rate or rates in force for that period which corresponds or correspond to that person's loss of earnings.

Transitional provision relating to review and appeal

7. Where a lesser incapacity allowance has been awarded to a person under the principal regulations before 15th November 1978 and a question arises as to the weekly rate of allowance payable in consequence of these regulations, the case shall be reviewed by the insurance officer in the light of amendments made by these regulations and the allowance shall continue to be payable at the weekly rate specified in the award until the question shall have been determined in accordance with the provisions of the principal regulations.

EXPLANATORY NOTE

(This note is not part of the regulations but is intended to indicate their general purport.)

These regulations further amend the Workmen's Compensation (Supplementation) Regulations (Northern Ireland) 1966 ("the principal regulations") by making adjustments to the intermediate rates of lesser incapacity allowance consequential upon the increase in the maximum rate of that allowance made by the Social Security Benefits Up-rating Order (Northern Ireland) 1978. The regulations also make transitional provisions consequent upon that Order.
