CRIMINAL DAMAGE

- Criminal Damage (Compensation) (Northern Ireland) Regulations 1978

Made.....14th March 1978Coming into operation...1st April 1978

To be laid before Parliament

The Secretary of State, in pursuance of articles 7 and 21(2) and (3) of the Criminal Damage (Compensation) (Northern Ireland) Order 1977(a), hereby makes the following regulations:

Citation and commencement

1. These regulations may be cited as the Criminal Damage (Compensation) (Northern Ireland) Regulations 1978 and shall come into operation on 1st April 1978.

Interpretation

2. In these regulations "the Order" means the Criminal Damage (Compensation) (Northern Ireland) Order 1977:

Preliminary notice of intention to apply for compensation

3.—(1) For the purposes of article 7(1)(c) of the Order, every person, other than the applicant or other person (if any) serving or causing the notice to be served, who has a mortgage, lien, charge or other legal interest in the property in question, shall be a prescribed person:

Provided that, where the property in question is held by the applicant under a lease or fee farm grant, for the purposes of the applicant's claim---

- (a) no lessor or grantor, other than the applicant's immediate lessor or grantor; or
- (b) no mortgagee of the reversion,

shall be a prescribed person.

(2) Such preliminary notice shall be in Form 1 in the Schedule.

Application for compensation

4.—(1) An application for compensation shall be in Form 2 in the Schedule.

(2) Where an application relates to damage to property which is subject to a mortgage to a building society, the applicant shall attach to his application a certificate by that society stating—

(a) the address of the property;

- (b) the nature of the applicant's estate or interest;
- (c) the name and address of the society; and

 - (d) that the society's solicitor has investigated the title to the property and, on a date specified in the certificate, considered that the title of the applicant was good and sufficient for the purposes of the society.

(3) In this regulation "building society" means a building society within the meaning of the Building Societies Act (Northern Ireland) 1967(b) or the Building Societies Act 1962(c).

Proof of service of preliminary notice

5.—(1) The person who, in accordance with article 7(1) of the Order, has served or caused to be served a preliminary notice of intention to apply for compensation shall furnish the Secretary of State with proof of such service (other than service on the Secretary of State) within fourteen days thereof.

(2) Where the notice was served other than by post, the service shall be verified by affidavit, or if it was served by registered post or by the recorded delivery service in accordance with section 24 of the Interpretation Act (Northern Ireland) 1954(d) by the original certificate of posting.

Reports and information from the Chief Constable

6. The Chief Constable shall furnish to the Secretary of State such reports and information as the Secretary of State may require regarding any damage or loss in respect of which a preliminary notice has been served under the Order or in respect of which an application for compensation has been made or as may otherwise appear to the Secretary of State to be necessary for the purposes of the due execution of the Order.

EXPLANATORY NOTE

These regulations prescribe the persons upon whom notice of intention to apply for compensation must be served under article 7 of the Criminal Damage (Compensation) (Northern Ireland) Order 1977. They prescribe the form of such notice and of the application for compensation under article 8 of the Order and also require that the Chief Constable shall furnish to the Secretary of State such reports and information as is specified in article 21(3) of the Order.
