# The Social Security (Miscellaneous Amendments) Regulations (Northern Ireland) 1978

Made 30th March 1978 3rd April 1978 Coming into operation

The Department of Health and Social Services for Northern Ireland, in exercise of the powers conferred on it by sections 3(2), 35(1), 37A(a), 49, 79(1), 80(2)(b)(b), 84, 85 and 126 of, and Schedule 17(c) to, the Social Security (Northern Ireland) Act 1975(d), and of all other powers enabling it in that behalf, hereby makes the following regulations:

## Citation, commencement and interpretation

- 1.—(1) These regulations may be cited as the Social Security (Miscellaneous Amendments) Regulations (Northern Ireland) 1978 and shall come into operation on 3rd April 1978.
- (2) Each provision of these regulations which amends other regulations shall be construed as one with the regulations which it amends.

### Amendment of the Social Security Benefit (Computation of Earnings) (Northern Ireland) Regulations 1975

2. In regulation 1 of the Social Security Benefit (Computation of Earnings) (Northern Ireland) Regulations 1975(e) (citation, commencement and interpretation), in paragraph (2) in the definition of "gainful employment" after "selfemployed earner" there shall be inserted "and any employment which would be such employment if it were in Northern Ireland".

## Amendment of the Social Security (Overlapping Benefits) Regulations (Northern Ireland) 1975

- 3.—(1) The Social Security (Overlapping Benefits) Regulations (Northern Ireland) 1975(f), as amended(g), shall be further amended in accordance with the following provisions of this regulation.
- (2) In regulation 6 (adjustment of dependency benefit in respect of a child where other dependency benefit is payable for that child), in paragraph (1) after "specified in paragraph (2) is payable" there shall be inserted "to that or any other person".

(3) For regulation 6A(h) there shall be substituted the following regulation-

### "Child Benefit

- 6A. Benefit under the Act shall not be required to be adjusted by reference to child benefit other than where an increase of child benefit is payable to a person who-
  - (a) either has no spouse or is not residing with his spouse; and
  - (b) is not living with any other person as his spouse,

and for the same period, in respect of the same child, any benefit or allowance or increase of a benefit or allowance under the Act is or, but for this regulation, would be payable to a beneficiary, the weekly rate of that benefit or allowance or increase thereof shall be reduced by the amount of the said increase of child benefit.".

(4) In regulation 12(i) (priority between persons entitled to increase of benefit), in paragraph (3)(a) for "has been awarded child benefit in respect of a child" there shall be substituted "is entitled, otherwise than by virtue of regulations made under Schedule 17 to the Act, to child benefit in respect of the child".

Amendment of the Social Security (Claims and Payments) Regulations (Northern Ireland) 1977

- 4.—(1) The Social Security (Claims and Payments) Regulations (Northern Ireland) 1977(j) shall be amended in accordance with the following provisions of this regulation.
- (2) For paragraph (5) of regulation 9 there shall be substituted the following paragraph—
  - "(5) A claim for benefit under the Supplementary Benefits (Northern Ireland) Order 1977(k) may be treated as a claim also for attendance allowance or an invalid care allowance.".
- (3) In Schedule 1 (prescribed times for claiming benefits and disqualifications for benefit arising by reason of late claims)—
  - (a) in column (1) in paragraph 4 after "invalidity pension," there shall be inserted "maternity allowance,";
  - (b) in column (2) there shall be substituted—
    - (i) for paragraph 4 the following paragraph—

"The period of 1 month from the day in respect of which the claim is made.",

(ii) for paragraph 11 the following paragraph—

"The period of 3 months from the first day on which the conditions for the receipt of that increase of benefit are satisfied.";

(c) in column (3) there shall be substituted for paragraph 4 the following paragraph-

"Benefit in respect of any day more than 1 month before the date on which the claim is made.".

- (4) In Schedule 2 (miscellaneous provisions) at the end of paragraph 2(1) there shall be added-
  - ", and where the person concerned claims an increase of that benefit or pension in respect of a child or adult dependant within the period of 1 month from the date of the claim to that benefit or pension, any such provision shall be deemed to be satisfied for the whole of the period in respect of which the claim to that benefit or pension is made".

### Amendment of the Social Security Benefit (Dependency) Regulations (Northern Ireland) 1977

- 5. In the Social Security Benefit (Dependency) Regulations (Northern Ireland) 1977(I), as amended(m)—
  - (a) in regulation 6 (circumstances in which a person who is not entitled to child benefit is to be treated as if he were so entitled), in paragraph (2) after "in respect of any child" there shall be inserted "ordinarily";
  - (b) in regulation 12 (prescribed circumstances for purposes of section 49 of the Social Security (Northern Ireland) Act 1975), there shall be added at the end of paragraph (1) ", except that section 47(1) shall not apply to a person over pensionable age entitled to non-contributory invalidity pension."

## Correction of the Social Security Benefit (Persons Abroad) (Amendment) Regulations (Northern Ireland) 1977

6. In regulation 3 of the Social Security Benefit (Persons Abroad) (Amendment) Regulations (Northern Ireland) 1977(n) (amendment of the Social Security (Attendance Allowance) Regulations (Northern Ireland) 1975(o) and the Social Security (Mobility Allowance) Regulations (Northern Ireland) 1975(p)) for "of each regulation" there shall be substituted "and paragraph (3) respectively".

#### Revocations

7. The regulations specified in column (1) of the Schedule to these regulations are hereby revoked to the extent mentioned in column (3) of that Schedule.

### EXPLANATORY NOTE

(This note is not part of the regulations but is intended to indicate their general purport.)

These regulations contain miscellaneous amendments to regulations made, or having effect as made, under the Social Security (Northern Ireland) Act 1975.

The regulations further amend the Social Security (Overlapping Benefits) Regulations (Northern Ireland) 1975 in their application to dependency benefit and child benefit, revise the provisions in the Social Security (Claims and Payments) Regulations (Northern Ireland) 1977 relating to prescribed times for claiming dependency benefit and extend the circumstances set out in the Social Security Benefit (Dependency) Regulations (Northern Ireland) 1977 in which a person is to be treated as entitled to child benefit during temporary periods of residence. The regulations also include minor and drafting amendments and revocations.
