The Department(a) of Agriculture, in exercise of the powers conferred on it by sections 13 and 53 of the Diseases of Animals Act (Northern Ireland) 1958(b), and of every other power enabling it in that behalf, hereby makes the following Order:

Citation and commencement

1. This Order may be cited as the Brucellosis Control (Amendment) Order (Northern Ireland) 1979 and shall come into operation on 30th April

Amendment of Order of 1972

- 2. The Brucellosis Control Order (Northern Ireland) 1972(c) is hereby amended as follows:
 - (1) In Article 2 after the definition of "reactor" there shall be inserted— ""veterinary clinic" means a veterinary clinic licensed by the Department of Agriculture for the examination and treatment of animals.".
 - (2) In Article 17—
 - (a) after paragraph (2)(c) there shall be added—
 - "(d) The provisions of paragraph (1) shall not apply to an animal being returned from a veterinary clinic to the herd from which it came.";
 - (b) for paragraph (3)(a) there shall be substituted—
 - "(3)(a) No animal, other than a castrated male animal, shall be moved on to premises on which is maintained a herd in which brucellosis infection has been found to exist unless—
 - (i) a period of at least 6 months has expired from the date on which a notice was served under Article 20(1)(i); and
 - (ii) a subsequent official test proves negative.".
 - (3) After Article 17 there shall be inserted the following Article—
 - "18. Notwithstanding the provisions of Articles 17 and 20 the Department of Agriculture may issue a licence, subject to such conditions as the Department of Agriculture considers necessary, authorising the movement of eligible animals on to premises on which is maintained a herd in which brucellosis infection has been found to exist.".

EXPLANATORY NOTE

(This note is not part of the Order, but is intended to indicate its general purport.)

This Order amends the Brucellosis Control Order (Northern Ireland) 1972 by enabling the Department of Agriculture to exempt from existing movement restrictions animals being returned to the herd from which they came following attendance at a licensed veterinary clinic.

The Order also empowers the Department of Agriculture to issue a licence, subject to conditions, authorising the movement of eligible animals on to premises on which is maintained a herd in which brucellosis infection has been found to exist.
