# Lands Tribunal (Salaries) Order (Northern Ireland) 1979

Made 25th June 1979

. 6th August 1979 Coming into operation

To be laid before Parliament under paragraph 3(3) of Schedule 1 to the Northern Ireland Act 1974

In exercise of the powers conferred by section 2(5) of the Lands Tribunal and Compensation Act (Northern Ireland) 1964(a) read with section 18 of the Administrative and Financial Provisions Act (Northern Ireland) 1962(b), and now vested in me(c) and of all other powers enabling me in that behalf, I hereby make the following Order:-

## Title and commencement

1. This Order may be cited as the Lands Tribunal (Salaries) Order (Northern Ireland) 1979 and shall come into operation on 6th August 1979.

### Revocation

2. Articles 3 and 4 of the Lands Tribunal (Salaries and Superannuation) Order (Northern Ireland) 1979(d) are hereby revoked.

## Increases in salaries

- 3.—(1) The annual salary payable to the President of the Lands Tribunal shall be increased, subject to Article 4, from 1st April 1979 from £18,250 to £20.250.
- (2) The annual salary payable to any other member of the Lands Tribunal shall be increased, subject to Article 4, from 1st April 1979 from £17,500 to £19,500.

#### Abatement

4. The annual salaries payable to members of the Lands Tribunal under Article 3 for the year ending 31st March 1980 shall be abated in the national interest by £1,585 in the case of the President and by £1,403 in the case of any other member.
