ROAD TRAFFIC AND VEHICLES

The 'Pelican' Pedestrian Crossings (Amendment) Regulations (Northern Ireland) 1979

Made 9th October 1979 . 19th November 1979 Coming into operation .

The Department of the Environment in exercise of the powers conferred by section 25 of the Road Traffic Act (Northern Ireland) 1970(a) and now vested in it(b) and of every other power enabling it in that behalf, hereby makes the following Regulations:

Citation and commencement

1. These Regulations may be cited as the 'Pelican' Pedestrian Crossings (Amendment) Regulations (Northern Ireland) 1979 and shall come into operation on 19th November 1979.

Regulations amended

- 2. The 'Pelican' Pedestrian Crossings Regulations (Northern Ireland) 1970(c) shall be amended as follows:—
 - (1) In sub-paragraphs (1)(b)(i), (1)(c) and (2)(b) of paragraph 5 of Part 1 of Schedule 1 for the words "the table in Part IV" in each place, substitute "either the table in Part IV or the table in Part V".

(2) After Part IV of Schedule 1 insert a new Part as follows:-

(3) In paragraph 1(2) of Schedule 2, for the words "as may be authorised in writing by the Ministry in the case of any particular crossing", substitute "as may be appropriate having regard to the layout of the carriageway and the extent to which it is used by pedestrians".

EXPLANATORY NOTE

(This note is not part of the Regulations, but is intended to indicate their general purport.)

These Regulations amend the 'Pelican' Pedestrian Crossing Regulations (Northern Ireland) 1970 so as to—

- (a) permit the width of a crossing to extend to a maximum of 10 metres without the authorisation in writing of the Department;
- (b) authorise an alternative phasing of the light signals. The effect of this would be to prolong the duration of the red signal to drivers so that it continues for a short time after the pedestrian flashing green phase has commenced thus giving pedestrians a little more time to complete the crossing.
