EDUCATION AND LIBRARY BOARDS

Education and Library Boards (Payments to Chairmen) Regulations (Northern Ireland) 1979

Made 30th November 1979 Coming into operation . 7th January 1980

The Department(a) of Education in exercise of the powers conferred on it by Articles 67(3)(b) and 125(1) of the Education and Libraries (Northern Ireland) Order 1972(c) (hereinafter referred to as "the Order") and section 18 of the Administrative and Financial Provisions Act (Northern Ireland) 1962(d) and of every other power enabling it in that behalf, with the approval of the Department of the Civil Service(e), hereby makes the following regulations:

Citation and commencement

- 1.—(1) These regulations may be cited as the Education and Library Boards (Payments to Chairmen) Regulations (Northern Ireland) 1979.
- (2) These regulations shall come into operation on 7th January 1980 and shall have effect as from 1st April 1979.

Interpretation

2. In these regulations "Chairman" means the person who is elected chairman by a board under paragraph 9(1) of Schedule 2 to the Order.

Payments to Chairmen

3. A board shall pay to its Chairman for or in relation to his functions as chairman of the board a sum not exceeding such amount as the Department may determine.

Revocation

4. The Education and Library Boards (Payments to Chairmen) Regulations (Northern Ireland) 1974(f) are hereby revoked.

EXPLANATORY NOTE

(This note is not part of the regulations, but is intended to indicate their general purport.)

These regulations, which replace the Education and Library Boards (Payments to Chairmen) Regulations (Northern Ireland) 1974, provide for the making of payments to the Chairmen of Education and Library Boards which are not to exceed amounts determined by the Department of Education.

The regulations have retrospective effect by virtue of section 18 of the Administrative and Financial Provisions Act (Northern Ireland) 1962.
