Off-Street Parking (Amendment) Bye-Laws (Northern Ireland) 1979

Made 21st March 1979 21st April 1979 Coming into operation

The Department of the Environment in exercise of the powers conferred by section 89 of the Road Traffic Act (Northern Ireland) 1970(a) and now vested in it(b) and of all other powers enabling it in that behalf hereby makes the following Bye-laws:-

Citation and commencement

1. These Bye-laws may be cited as the Off-Street Parking (Amendment) Bye-laws (Northern Ireland) 1979 and shall come into operation on 21st April 1979.

Bye-laws amended

- 2. The Off-Street Parking Bye-laws (Northern Ireland) 1976(c) shall be amended as follows:-
 - (a) by the deletion from Schedule 1 Part I of the car parks included in Schedule 1:
 - (b) by the substitution for the Scale of Charges specified in Column 2 of Part II of Schedule 1 in relation to Tariff B, C, D and E of the Scale of Charges set out in Schedule 2;
 - (c) by the substitution for item 19 Part I of Schedule 1 of the provisions in Schedule 3.
