## Maintenance Allowances (Pupils over Compulsory School Age) (Amendment) Regulations (Northern Ireland) 1980

The Department(a) of Education in exercise of the powers conferred on it by Articles 39(1) and (2)(b) and 125(1) of the Education and Libraries (Northern Ireland) Order 1972(c) and of every other power enabling it in that behalf, hereby makes the following Regulations:

#### Citation and commencement

1.—(1) These Regulations may be cited as the Maintenance Allowances (Pupils over Compulsory School Age) (Amendment) Regulations (Northern Ireland) 1980.

(2) These Regulations shall come into operation on 1st September 1980.

#### Revocation

2. The Maintenance Allowances (Pupils over Compulsory School Age) (Amendment) Regulations (Northern Ireland) 1979(d) are hereby revoked.

#### Amendments

3. The Maintenance Allowances (Pupils over Compulsory School Age) Regulations (Northern Ireland) 1973(e) shall be amended as follows:

(a) For paragraph 1 of the Schedule there shall be substituted:

"1. The amount of a maintenance allowance shall be determined in accordance with the following table:

# EXPLANATORY NOTE

(This note is not part of the Regulations, but is intended to indicate their general purport.)

These Regulations introduce improved rates of maintenance allowances in respect of pupils over compulsory school age following full-time courses at grant-aided schools or institutions of further education. The Regulations also enlarge the amounts which, in the calculation of these allowances, may be set against gross parental income in respect of other dependants.
