(Northern Ireland) 1980**

Made 29th July 1980
Coming into operation 29th July 1980

The Department of Health and Social Services, in exercise of the powers conferred on it by Article 1(3) of the Social Security (No. 2) (Northern Ireland) Order 1980(a), and of all other powers enabling it in that behalf, hereby makes the following order:

Citation, commencement and interpretation

1.—(1) This order may be cited as the Social Security (1980 No. 2 Order) (Commencement) Order (Northern Ireland) 1980, and shall come into operation on 29th July 1980.

(2) In this order “the No. 2 Order” means the Social Security (No. 2) (Northern Ireland) Order 1980.

Appointed days

2. The day appointed for the coming into operation of each provision of the No. 2 Order which is specified in column (1) of the Schedule shall be the date specified in column (3) of that Schedule in relation to that provision.

EXPLANATORY NOTE

(This note is not part of the order but is intended to indicate its general purport.)

This order brings into operation, with effect from the dates specified in the Schedule to the order, those provisions of the Social Security (No. 2) (Northern Ireland) Order 1980 which did not come into operation on the making of that Order (ie on 28th July 1980).
