The Department(a) of Finance, in exercise of the powers conferred on it by section 12 of the Public Health and Local Government (Miscellaneous Provisions) Act (Northern Ireland) 1955(b) and by section 14 of the Administrative and Financial Provisions Act (Northern Ireland) 1956(c) and paragraph 18 of Schedule 6 to the Local Government Act (Northern Ireland)  $1972(\mathbf{d})$  and of every other power enabling it in that behalf hereby makes the following Order:

**1.** This Order may be cited as the Compulsory Acquisition (Interest) (No. 3) Order (Northern Ireland) 1980 and shall come into operation on 22nd September 1980.

2. The Compulsory Acquisition (Interest) (No. 2) Order (Northern Ireland) 1980(e) is hereby revoked.

3. The rate of interest payable by virtue of section 22 of the Local Government Act (Northern Ireland) 1934(f), paragraph 22 of Schedule 5 to the Roads Act (Northern Ireland) 1948(g) or paragraph 18 of Schedule 6 to the Local Government Act (Northern Ireland) 1972 on compensation money in respect of land compulsorily acquired shall, in respect of any period after the coming into operation of this Order, be 16 per centum per annum.
