College of Education Salaries (Amendment No. 3) Regulations  
(Northern Ireland) 1980

Made . . . . . 4th September 1980

Coming into operation . . . . . 30th September 1980

The Department(a) of Education, in pursuance of the powers conferred on it by Articles 57(1) and 125(1) of the Education and Libraries (Northern Ireland) Order 1972(b) and section 18 of the Administrative and Financial Provisions Act (Northern Ireland) 1962 (c) and of every other power enabling it in that behalf, after consultation with the Department(a) of Finance hereby makes the following regulations:

PART I  
GENERAL*Citation and commencement*

1.—(1) These regulations may be cited as the College of Education Salaries (Amendment No. 3) Regulations (Northern Ireland) 1980.

(2) These regulations shall come into operation on 30th September 1980 and shall have effect:—

(a) for the purposes of Part II on and from 1st April 1980;

(b) for the purposes of Part III on and from 1st September 1980.

*Amendment of Principal Regulations*

2. The College of Education Salaries Regulations (Northern Ireland) 1975(d) are hereby amended in accordance with the following provisions of these regulations and references in these regulations to a numbered regulation or schedule are references to the regulation or schedule so numbered in those regulations.

PART II  
AMENDMENTS HAVING EFFECT ON AND FROM 1st APRIL 1980*Substitutions*

3.—(1) In Regulation 6(3) and (4) (salary scales and salary ranges) for “paragraph 2” there shall be substituted “paragraph 7”.

(2) In Regulation 6(5)(e) (salary scales and salary ranges) for “paragraph 3” there shall be substituted “paragraph 8”.

(3) In Regulation 8 (allowances for heads of department) for “£864”(f) and “£765”(f) there shall be substituted “£978” and “£864” respectively.

(4) In paragraphs 1, 7 and 8 of Schedule 1(f) for the existing tables of salary scales there shall be substituted the respective tables of salary scales set out in Annex A.

*Addition*

4. At the end of paragraph 6(3)(f) of Schedule 1 (allowances for principal lecturers) there shall be inserted—

“The allowance so determined shall be further increased by 13% (rounded to the nearest multiple of £3) with effect from 1st April 1980.”

## PART III

## AMENDMENTS HAVING EFFECT ON AND FROM 1st SEPTEMBER 1980

*Substitutions*

5.—(1) In Regulation 8 (allowances for heads of department) for “£978” and “£864” as inserted by Part II, there shall be substituted “£1086” and “£954” respectively.

(2) In paragraphs 1, 7 and 8 of Schedule 1 for the tables of salary scales as inserted by Part II, there shall be substituted the respective tables of salary scales set out in Annex B.

(3) For the last sentence of paragraph 6(3) of Schedule 1 (allowances for principal lecturers) as inserted by Part II, there shall be substituted—

“The allowance so determined shall be further increased by 25% (rounded to the nearest multiple of £3) with effect from 1st September 1980.”

## EXPLANATORY NOTE

*(This note is not part of the Regulations, but is intended to indicate their general purport.)*

These regulations relate to teachers employed in colleges of education and amend the College of Education Salaries Regulations (Northern Ireland) 1975.

The regulations introduce from 1st April 1980 and 1st September 1980 respectively, revised scales of salaries for teachers in colleges of education.

The regulations also provide for increased rates of allowances in certain cases with effect from 1st April 1980 and 1st September 1980 respectively.

Where the regulations have retrospective effect this is by virtue of section 18 of the Administrative and Financial Provisions Act (Northern Ireland) 1962.
