## Institutions of Further Education Salaries (Amendment No. 5) **Regulations (Northern Ireland) 1980**

The Department(a) of Education, in exercise of the powers conferred on it by Articles 57(1) and 125(1) of the Education and Libraries (Northern Ireland) Order 1972(b) and by section 18 of the Administrative and Financial Provisions Act (Northern Ireland) 1962(c) and of every other power enabling it in that behalf, after consultation with the Department(a) of Finance, hereby makes the following regulations:

#### Citation and commencement

1. These regulations may be cited as the Institutions of Further Education Salaries (Amendment No. 5) Regulations (Northern Ireland) 1980 and shall come into operation on 28th November 1980 and except where otherwise provided shall have effect on and from 1st April 1980.

#### Amendment of regulations

2. The Institutions of Further Education Salaries Regulations (Northern Ireland) 1976(d) are hereby amended in accordance with the following provisions of these regulations and references in these regulations to a numbered regulation are references to the regulation so numbered in the Institutions of Further Education Salaries Regulations (Northern Ireland) 1976.

#### Payment of part-time teachers

**3.**—(1) In the table in regulation 29 for the rates per hour of " $\pounds$ 7.43", " $\pounds$ 6.93", " $\pounds$ 5.62", " $\pounds$ 4.71" and " $\pounds$ 3.98" there shall be substituted " $\pounds$ 8.40", " $\pounds$ 7.85", " $\pounds$ 6.41", " $\pounds$ 5.35" and " $\pounds$ 4.60" respectively.

(2) With effect on and from 1st September 1980 in the table in regulation 29 for the rates per hour of " $\pounds 8.40$ ", " $\pounds 7.85$ ", " $\pounds 6.41$ ", " $\pounds 5.35$ " and " $\pounds 4.60$ " there shall be substituted " $\pounds 9.25$ ", " $\pounds 8.65$ ", " $\pounds 7.10$ ", " $\pounds 6.00$ " and " $\pounds 5.35$ " respectively.

## EXPLANATORY NOTE

# (This note is not part of the Regulations, but is intended to indicate their general purport.)

These regulations introduce from 1st April 1980 and from 1st September 1980 revised rates of pay for part-time teachers employed in recognised institutions of further education.
