BUILDING SOCIETIES**Building Societies (Fees) (Amendment) Regulations (Northern Ireland) 1980***Made* 18th February 1980*Coming into operation* 1st April 1980

The Registrar, in exercise of the powers conferred upon him by section 123(1) of the Building Societies Act (Northern Ireland) 1967(a), and of every other power enabling him in that behalf, and with the consent of the Department (b) of Commerce, hereby makes the following regulations:

Citation and commencement

1. These regulations may be cited as the Building Societies (Fees) (Amendment) Regulations (Northern Ireland) 1980 and shall come into operation on 1st April 1980.

Revocation

2. The Building Societies (Fees) (Amendment) Regulations (Northern Ireland) 1979(c) are hereby revoked.

Amendment of fees

3. For Schedule 2 to the Building Societies (Forms and Fees) Regulations (Northern Ireland) 1968(d) (as substituted by the Building Societies (Fees) (Amendment) Regulations (Northern Ireland) 1979) there shall be substituted the following Schedule:

For registration of a transfer of engagements, where the transferring society, whether or not it is a society of Great Britain, has—	£

For a document certified as a true copy of a document in the custody of the Registrar, where the copy so certified is not made by the Registrar, 90p for the examination of such copy and, if the copy exceeds 216 words, for every additional folio of 72 words or part thereof, 18p (in addition to the fee for the signature of the Registrar)."

EXPLANATORY NOTE

(This note is not part of the Regulations, but is intended to indicate their general purport.)

These regulations increase by 50% the fees payable in connection with the exercise by the Registrar of his functions under the Building Societies Act (Northern Ireland) 1967, except that the fee payable on an application for the right to obtain names and addresses from the register of members of a building society is reduced from £26 to £5.

They supersede the Building Societies (Fees) (Amendment) Regulations (Northern Ireland) 1979.
