# Charges for Drugs and Appliances (Amendment) Regulations (Northern Ireland) 1980

The Department(a) of Health and Social Services in exercise of the powers conferred on it by Articles 98, 106 and 107 of, and Schedule 15 to, the Health and Personal Social Services (Northern Ireland) Order 1972(b) and of all other powers enabling it in that behalf, with the approval of and in conjunction with the Department(a) of Finance, hereby makes the following regulations:

#### Citation and commencement

1. These regulations may be cited as the Charges for Drugs and Appliances (Amendment) Regulations (Northern Ireland) 1980 and shall come into operation on 1st April 1980.

### Amendment of regulations

- 2. The Health and Personal Social Services (Charges for Drugs and Appliances) Regulations (Northern Ireland) 1973(c) shall be further amended as follows:
  - (a) in regulations 3(1)(b), 3(3), 5(1)(b), 7(1)(b), 7(2)(b) and 7(3) for "£0.45" there shall be substituted "£0.70";
  - (b) in regulation 6(2) and 6(4) for "six" there shall be substituted "four" and in regulation 6(4) for "£8.00" there shall be substituted "£12.00";
  - (c) in regulation 15(1)(d)(ii) the word "endocrine" shall be omitted;
  - (d) in regulation 15(1)(f)(ii)(B)(1) for "£0.65" there shall be substituted "£1.00";
  - (e) for Schedules 1 and 2 there shall be substituted the following two Schedules—

# **EXPLANATORY NOTE**

(This note is not part of the Regulations, but is intended to indicate their general purport.)

These regulations further amend the Health and Personal Social Services (Charges for Drugs and Appliances) Regulations (Northern Ireland) 1973. The amendments increase the charges specified for the supply of drugs and certain appliances under the Health and Personal Social Services (Northern Ireland) Order 1972, reduce to four months the period of the six month prepayment certificate of exemption from some of those charges, increase the sum prescribed for the twelve month prepayment certificate of exemption and increase the allowance for exemption from those charges on grounds of low income, and make a correction.
