MINERAL DEVELOPMENT

Mineral Development (Fees) (Amendment) Regulations
(Northern Ireland) 1981

Made	5th June 1981
Coming into operation	1st July 1981

The Department(a) of Commerce, in exercise of the powers conferred upon it by section 49 of the Mineral Development Act (Northern Ireland) 1969(b) and of every other power enabling it in that behalf, with the approval of the Department(c) of Finance, hereby makes the following Regulations:—

Citation and commencement

1. These Regulations may be cited as the Mineral Development (Fees) (Amendment) Regulations (Northern Ireland) 1981 and shall come into operation on 1st July 1981.

Amendment of fees

2. For Regulation 5(1) of the Mineral Development (Applications, Fees and Model Clauses) Regulations (Northern Ireland) 1970(d) there shall be substituted:—

“5.—(1) With every application there shall be forwarded to the Department the appropriate fee computed in accordance with the following Table:—

<i>Subject of Application</i>	<i>Amount or rate of fee</i>
Prospecting licence	£17.50 for each licence
Mining lease	£35.00 for each acre or part of an acre (£86.49 for each hectare or part of a hectare) contained in the area comprised in the lease application
Mining licence	£17.50 for each acre or part of an acre (£43.24 for each hectare or part of a hectare) contained in the area comprised in the licence application
Mining permission	£7.00 for each acre or part of an acre (£17.30 for each hectare or part of a hectare) contained in the area comprised in the permission application
Mining facilities permit	£35.00 for each acre or part of an acre (£86.49 for each hectare or part of a hectare) contained in the area comprised in the permit application.”

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These Regulations amend the Mineral Development (Applications, Fees and Model Clauses) Regulations (Northern Ireland) 1970 and prescribe increased fees for the granting of prospecting licences, mining leases, mining licences, mining permissions and mining facilities permits under the Mineral Development Act (Northern Ireland) 1969.
