MAGISTRATES' COURTS**The Magistrates' Courts Fees (Amendment) Order
(Northern Ireland) 1981***Made**1st June 1981**Coming into operation**22nd June 1981*

The Lord Chancellor, in exercise of the powers conferred on him by section 116(1) of the Judicature (Northern Ireland) Act 1978(a), after consultation with the Lord Chief Justice and with the concurrence of the Treasury, hereby makes the following Order:—

1. This Order may be cited as the Magistrates' Courts Fees (Amendment) Order (Northern Ireland) 1981 and shall come into operation on 22nd June 1981.

2. For Schedule 1 to the Magistrates' Courts Fees Order (Northern Ireland) 1979(b) there shall be substituted the following Schedule:—

EXPLANATORY NOTE

(This note is not part of the Order.)

This Order amends the Magistrates' Courts Fees Order (Northern Ireland) 1979 by substituting a new schedule of fees to be taken in magistrates' courts.

The fee payable in respect of certain licensing and registration applications is increased from £10 to £13, but all other fees are unchanged.
