**The Companies (1978 Order) (Commencement No. 4)  
Order (Northern Ireland) 1981**

The Department of Commerce, in exercise of the powers conferred on it by Article 1(1) of the Companies (Northern Ireland) Order 1978(a) read with paragraph 2(1)(b) of Schedule 1 of the Northern Ireland Act 1974(b), hereby makes the following Order:

*Citation*

1. This Order may be cited as the Companies (1978 Order) (Commencement No. 4) Order (Northern Ireland) 1981.

*Commencement*

2. The provisions of the Companies (Northern Ireland) Order 1978 specified in the Schedule shall come into operation on 4th January 1982.

## EXPLANATORY NOTE

*(This note is not part of the Order.)*

This Order brings into operation on 4th January 1982 Article 153(2) of the Companies (Northern Ireland) Order 1978 insofar as that Article repeals, or repeals words in, certain statutory provisions (relating to fees) which are contained in Schedule 7 to the Order of 1978. This commencement Order also brings into operation related provisions of Schedule 7.

The statutory provisions to be repealed appoint or prescribe fees to be paid to the registrar of companies for the exercise of certain of his functions under the Companies Acts.

Article 146 of the Order of 1978 has substituted a fresh section 373 in the Companies Act (Northern Ireland) 1960. Section 373 confers power to prescribe fees for the exercise of the functions of the registrar.
