**The Pollution Control and Local Government (1978 Order)
(Commencement No. 3) Order (Northern Ireland) 1981**

Made *18th March 1981*

The Department of the Environment, in exercise of the powers conferred on it by Article 1(2) of the Pollution Control and Local Government (Northern Ireland) Order 1978(a) (hereinafter referred to as "the Order") and paragraphs 2(1) and 2(2) of Schedule 1 to the Northern Ireland Act 1974(b) and of every other power enabling it in that behalf, hereby makes the following Order:—

Citation

1. This Order may be cited as the Pollution Control and Local Government (1978 Order) (Commencement No. 3) Order (Northern Ireland) 1981.

2. The day appointed for the coming into operation of the provisions of the Order which are specified in column 1 of the Schedule and which relate to the subject matter specified in column 2 thereof shall be 23rd March 1981.

EXPLANATORY NOTE

(This note is not part of the Order.)

This Order brings certain provisions of the Pollution Control and Local Government (Northern Ireland) Order 1978 into force on 23rd March 1981, which provide for the amendment of the Clean Air Act (Northern Ireland) 1964.

The amendments relate to the prohibition of dark smoke from industrial and trade premises; the emission of grit and dust from furnaces; the requirement to fit arrestment plant to new furnaces and exemption therefrom; the measurement of grit and dust from furnaces; the height of chimneys serving a furnace; the application to fumes of certain provisions as to grit and dust; smoke control areas; new buildings overreaching adjacent chimneys and increased penalties for certain offences.
