STATUTORY RULES

Statutory Rules (Exemption) Regulations (Northern Ireland) 1982

Made 7th July 1982 Coming into operation 1st September 1982

The Department of Finance and Personnel(a) (hereinafter called "the Department'') in exercise of the powers conferred on it by Articles 5(2)(c) and 7(1)and (2) of the Statutory Rules (Northern Ireland) Order 1979(b) and paragraphs 2(1) and (2) and 3(7) of Schedule 1 to the Northern Ireland Act 1974(c) and of every other power enabling it in that behalf and with the concurrence of the Lord Chief Justice, hereby makes the following regulations:

Citation and commencement

1. These regulations may be cited as the Statutory Rules (Exemption) Regulations (Northern Ireland) 1982 and shall come into operation on 1st September 1982.

Exemption from requirements as to printing and sale

2. Orders made by the Department of the Environment under Article 25(1) of the Road Traffic (Northern Ireland) Order 1981(d) (which control the use of traffic of roads affected by roadworks and as respects which the Department is satisfied that adequate arrangements exist for bringing so far as is reasonably practicable notice of their making to persons appearing to be affected by them and for supplying copies of them to persons applying for such copies) are hereby exempted from the requirements of Article 5(2)(c) of the Statutory Rules (Northern Ireland) Order 1979 (which requires arrangements to be made for the printing and sale of statutory rules).
