The Social Security (1982 Order) (Commencement) Order (Northern Ireland) 1982

The Department of Health and Social Services, in exercise of the powers conferred on it by Article 1(2) of the Social Security (Northern Ireland) Order 1982(a), paragraph 2(1) and (2) of Schedule 1 to the Northern Ireland Act 1974(b) and of all other powers enabling it in that behalf, hereby makes the following order:

Citation and interpretation

- 1.—(1) This order may be cited as the Social Security (1982 Order) (Commencement) Order (Northern Ireland) 1982.
- (2) In this order "the Order" means the Social Security (Northern Ireland) Order 1982.

Appointed days

2. The day appointed for the coming into operation of each provision of the Order which is specified in column (1) of the Schedule shall be the date specified in column (3) of that Schedule in relation to that provision.

This order brings into operation on 6th April 1983 all those provisions of the Social Security (Northern Ireland) Order 1982 ("the 1982 Order") which relate to statutory sick pay and which did not come into operation on 10th August 1982 in accordance with Article 1(2) of the 1982 Order and (with a minor exception) all those provisions which relate to the abolition of injury benefit.

It also brings into operation the remaining miscellaneous provisions of the 1982 Order on various dates in 1982.
