ULSTER SAVINGS CERTIFICATES

Ulster Savings Certificates (Twenty-fourth Issue) (Amendment)
Regulations 1982

Made 31st August 1982

Coming into operation 1st September 1982

The Department of Finance and Personnel(a) in exercise of the powers conferred upon it by Section 15(1) of the Exchequer and Financial Provisions Act (Northern Ireland) 1950(b) and of every other power enabling it in that behalf hereby makes the following regulations:

1. These regulations may be cited as the Ulster Savings Certificates (Twenty-fourth Issue) (Amendment) Regulations 1982 and shall come into operation on 1st September 1982.

2. Schedule 3 to the Ulster Savings Certificates Regulations 1962(c) (which Schedule prescribes the maximum number of unit Certificates which may be held) shall be further amended by substituting for paragraph (g) of the said Schedule the following paragraph:—

“(g) Two hundred in the case of Certificates issued on or after 19th April 1982 (known as the Twenty-fourth Issue).”

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These regulations amend Ulster Savings Certificates Regulations 1962 by increasing the maximum permitted holding of Ulster Savings Certificates of the Twenty-fourth Issue from 100 units (£2,500) to 200 units (£5,000) as from 1st September 1982. The Twenty-fourth Issue was introduced by the Ulster Savings Certificates (Twenty-fourth Issue) Regulations 1982 (S.R. 1982 No. 92).
