To be laid before Parliament

The Secretary of State, in pursuance of section 10 of the Police Act (Northern Ireland) 1970(a), read with section 18 of the Administrative and Financial Provisions Act (Northern Ireland) 1962(b), and after consulting, in accordance with section 34(2) of the said Act of 1970, the Police Authority for Northern Ireland and the Police Association for Northern Ireland and, in accordance with section 2(1) of the Police Negotiating Board Act 1980(c), the Police Negotiating Board for the United Kingdom, hereby, with the concurrence of the Treasury, makes the following regulations:—

Citation, commencement and effect

1.—(1) These regulations may be cited as the Police Cadets (Amendment) Regulations (Northern Ireland) 1982.

(2) These regulations shall come into operation on 1st December 1982 and shall have effect for the purposes of regulation 6 as from 1st September 1981.

Interpretation

2. In these regulations any reference to the principal regulations is a reference to the Police Cadets Regulations (Northern Ireland) 1980(d).

Notice of conditions of service

3. After regulation 4 of the principal regulations there shall be inserted the following regulation:—

"Notice of conditions of service

4A. A candidate for appointment as a police cadet shall be given a notice describing the conditions of service relating to the appointment."

Termination of service

4. In paragraph (5) of regulation 5 of the principal regulations the words "for misconduct" shall be omitted.

Medical examination

5. Regulation 12 of the principal regulations shall be omitted.

Pay

6. For the Table in Schedule 2 to the principal regulations there shall be substituted the following Table:—

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These regulations amend the Police Cadets Regulations (Northern Ireland) 1980.

Regulation 3 entitles a police cadet to a notice of conditions of service.

Regulation 4 extends the right of a cadet to a personal interview at which he may make representations to all cases where the chief constable is considering terminating his service.

Regulation 5 removes the requirement that a cadet shall be medically examined at 6-monthly intervals.

Regulation 6 increases the pay of Police Cadets from 1st September 1981.

Regulation 7 increases the annual charge payable by cadets for board and lodging provided by the Police Authority.

Retrospective effect for regulation 6 is authorised by section 18 of the Administrative and Financial Provisions Act (Northern Ireland) 1962.
