## ULSTER SPECIAL CONSTABULARY PENSIONS

# **Ulster Special Constabulary Pensions (Amendment) Regulations 1982**

25th October 1982 Made Coming into operation 15th December 1982

The Secretary of State, in pursuance of section 1 of the Special Constables Act 1914(a) (as extended and amended by section 8 of the Constabulary Act (Northern Ireland) 1922(b)), and section 4(4) of the Constabulary (Pensions) Act (Northern Ireland) 1949(c), read with section 33(2) of the Police Act (Northern Ireland) 1970(d) and with Articles 14 and 15 of the Superannuation Order 1972(e) hereby makes the following regulations:----

## PART I

#### CITATION, COMMENCEMENT AND INTERPRETATION

## Citation, commencement and effect

1. These regulations may be cited as the Ulster Special Constabulary Pensions (Amendment) Regulations 1982 and shall come into operation on 15th December 1982 but shall have effect as from 24th November 1980 except for regulation 4 which shall have effect as from 12th November 1979.

#### Interpretation

2. In these regulations "the principal regulations" means the Ulster Special Constabulary Pensions Regulations 1950(f).

## PART II

#### Amendments to the Regulations of 1950

## Insertion of regulation 32B

3. After regulation 32A there shall be added the following regulation:-

"Awards not based on pension or notional pension

32B. The Seventh Schedule shall have effect for the purpose of calculating the amount of certain awards to widows or children under these regulations which are not calculated by reference to the pension or notional pension of the husband or parent.".

# Application of the Social Security Pensions (Northern Ireland) Order 1975(a)

**4.**—(1) In regulation 52D after the words "section 2, of that Act" there shall be inserted the words "or Article 69 of the Social Security Pensions (Northern Ireland) Order 1975".

(2) In sub-paragraphs (b), (c) and (d) of the said regulation 52D for the words "that Act", in each place where they occur, there shall be substituted the words "the said Act of 1971".

## Widow's ordinary pension

5. For paragraph 1 of Part I of the Second Schedule to the principal regulations there shall be substituted the following provision:—

"1. Subject to paragraph 2, the weekly amount of a widow's ordinary pension shall be calculated in accordance with paragraph 1 of the Seventh Schedule by reference to the rank held by her husband at the time when he ceased to be a member.".

## Widow's ordinary pension – standard rate

**6.** For paragraph 3 of Part VIII of the Second Schedule to the principal regulations there shall be substituted the following provision:—

"3. Where in respect of any period the widow so elects, then, subject to paragraph 4, the weekly amount of her ordinary pension in respect of that period shall be calculated in accordance with paragraph 1 of the Seventh Schedule by reference to the rank held by her husband at the time when he ceased to be a member."

#### Child's ordinary allowance

7. In Part I of the Third Schedule to the principal regulations for paragraphs 1 and 2 there shall be substituted the following provisions:—

"1. Subject as hereafter in this Schedule provided, a child's ordinary allowance shall be the weekly amount calculated in accordance with paragraph 2 of the Seventh Schedule by reference to the rank which the relevant parent held at the time when he ceased to be a member.

2. Where both parents of the child are dead at the time when the allowance became payable, the child's ordinary allowance shall be the weekly amount calculated in accordance with paragraph 3 of the Seventh Schedule by reference to the rank which the parent in respect of whose death the allowance is payable held at the time when he ceased to be a member.".

# Special provisions about awards not based on pension or notional pension

8. After the Sixth Schedule to the principal regulations there shall be inserted the following provisions:—

## "SEVENTH SCHEDULE

## SPECIAL PROVISIONS ABOUT AWARDS NOT BASED ON PENSION OR NOTIONAL PENSION

1.—(1) In any week the amount of a widow's pension under paragraph 1 of Part I of the Second Schedule or paragraph 3 of Part VIII of that Schedule shall be the appropriate sum specified in sub-paragraph (2) increased in accordance with paragraph 4.

(2) The appropriate sum for the purposes of sub-paragraph (1) shall be, where her husband at the time he ceased to be a member —

(a) held a rank higher than that of Paymaster,  $\pounds 11.39$ ;

(b) held the rank of Paymaster,  $\pm 9.87$ ;

(c) held a rank lower than that of Paymaster, £8.43,

increased in each case by 56p if the pension is payable under the said paragraph 3 and the husband was entitled to reckon at least 10 years' pensionable service.

2.—(1) In any week the amount of an allowance under paragraph 1 of Part I of the Third Schedule shall be the appropriate sum specified in sub-paragraph (2) increased in accordance with paragraph 4.

(2) The appropriate sum for the purposes of sub-paragraph (1) shall be, if the relevant parent at the time he ceased to be a member—

- (i) held a rank higher than that of Paymaster, £3.48;
- (ii) held the rank of Paymaster, £3.02;
- (iii) held a rank lower than that of Paymaster, £2.77.

3.—(1) In any week the amount of an allowance under paragraph 2 of Part I of the Third Schedule shall be the appropriate sum specified in sub-paragraph (2) increased in accordance with paragraph 4.

(2) The appropriate sum for the purposes of sub-paragraph (1) shall be, if the relevant parent at the time he ceased to be a member -

- (i) held a rank higher than that of Paymaster, £5.73;
- (ii) held the rank of Paymaster, £4.92;
- (iii) held a rank lower than that of Paymaster, £4.24.

4.—(1) Subject to sub-paragraph (2) a sum specified in a preceding paragraph shall be increased to the amount which would be payable in the relevant week in respect of a corresponding official pension having regard to relevant orders under Article 69 of the Social Security Pensions (Northern Ireland) Order 1975 and as if for any reference to an annual rate in the relevant orders there were substituted a reference to a weekly rate.

(2) For the purposes of sub-paragraph (1) above---

- (a) the reference to an official pension means an official pension, within the meaning of the Pensions (Increase) Act (Northern Ireland) 1971(a), which began on 30th June 1978, and
- (b) in performing the necessary calculations sums shall be expressed to the nearest penny (a half penny to count as one penny).".

# EXPLANATORY NOTE

# (This note is not part of the Regulations.)

These regulations amend the Ulster Special Constabulary Pensions Regulations 1950. Regulation 4 has effect from 12th November 1979 but the other regulations have effect from 24th November 1980 (retrospection is authorised by Articles 14 and 15 of the Superannuation (Northern Ireland) Order 1972).

Regulation 4 amends regulation 52D of the Ulster Special Constabulary Pensions Regulations 1950 which provides for certain awards under those regulations to be increased by reference to the Pensions (Increase) Act (Northern Ireland) 1971. The increases under that regulation are calculated by reference to Orders made under section 2 of the 1971 Act but with effect from 12th November 1979 the relevant Orders are made under Article 69 of the Social Security Pensions (Northern Ireland) Order 1975. Regulation 4 inserts a reference to Orders under the 1975 Order with effect from 12th November 1979.

The remaining amendments to the 1950 Regulations are concerned with awards which are at present of specified amounts. These amounts have been increased by amending regulations in line with the increases in pensions made by the Pensions (Increase) Act (Northern Ireland) 1971 and the Social Security Pensions (Northern Ireland) Order 1975. The amendments made by these regulations ensure that the amounts of these awards will increase automatically in line with increases in pensions under the 1975 Order and will so avoid the need for frequent amending regulations.
