The Department of Economic Development, in exercise of the powers conferred by Article 49(1)(a) and (b) of the Industrial Assurance (Northern Ireland) Order 1979(a) (hereinafter called "the Order") and now vested in it(b) and of every other power enabling it in that behalf, with the approval of the Department of Finance and Personnel(c), hereby makes the following regulations:

Citation and commencement

1. These regulations may be cited as the Industrial Assurance (Fees) Regulations (Northern Ireland) 1983 and shall come into operation on 1st July 1983.

Fees

2.—(1) The fees specified in the Schedule shall be payable to the Department of Economic Development in respect of the matters set out therein.

(2) The fees mentioned in paragraph (1) shall be payable in advance.

Revocation

3. The Industrial Assurance (Fees) Regulations (Northern Ireland) 1982(d) are hereby revoked.

These regulations supersede the Industrial Assurance (Fees) Regulations (Northern Ireland) 1982.
