## Police Cadets (Amendment No. 2) Regulations (Northern Ireland) 1983

Made 7th November 1983 Coming into operation 1st December 1983

To be laid before Parliament

The Secretary of State, in pursuance of section 10 of the Police Act (Northern Ireland) 1970(a), read with section 18 of the Administrative and Financial Provisions Act (Northern Ireland) 1962(b), and after consulting, in accordance with section 34(2) of the said Act of 1970, the Police Authority for Northern Ireland and the Police Association for Northern Ireland and, in accordance with section 2(1) of the Police Negotiating Board Act 1980(c), the Police Negotiating Board for the United Kingdom, hereby, with the concurrence of the Treasury, makes the following regulations:-

## Citation, commencement and effect

- 1.—(1) These regulations may be cited as the Police Cadets (Amendment No. 2) Regulations (Northern Ireland) 1983.
- (2) These regulations shall come into operation on 1st December 1983 and shall have effect for the purposes of regulation 3 as from 1st September 1983.

## Interpretation

2. In these regulations any reference to the principal regulations is a reference to the Police Cadets Regulations (Northern Ireland) 1980(d).

#### Pay

3. For the Table in Schedule 2 to the principal regulations there shall be substituted the following Table:-

Under 17 years	£2,532
17 years	£2,685
18 years	£2,988"

# Charge for board and lodging

4. In Schedule 3 to the principal regulations for "£339" there shall be substituted "£354".

#### EXPLANATORY NOTE

(This note is not part of the Regulations.)

These regulations amend the Police Cadets Regulations (Northern Ireland) 1983.

Regulation 3 increases the pay of cadets from 1st September 1983.

Regulation 4 increases the annual charge payable by cadets for board and lodging provided by the Police Authority.

Retrospective effect for regulation 3 is authorised by section 18 of the Administrative and Financial Provisions Act (Northern Ireland) 1962.
