2.—(1) Subject to paragraph (2) all provisions of the Companies (Northern Ireland) Order 1978 not yet in operation, shall insofar as they confer or affect any power to make regulations and orders come into operation on 11th December 1983, and shall for all other purposes come into operation on 1st January 1984.

(2) Paragraph (1) does not apply to the provisions set out in the Schedule to the extent mentioned in that Schedule.

EXPLANATORY NOTE

(This note is not part of the Order.)

This Order brings into operation provisions of the Companies (Northern Ireland) Order 1978 relating to the winding up of companies. These provisions require the Department of Economic Development to keep an Insolvency Account, provide for the treatment of unclaimed dividends and re-enact provisions of the Companies (Amendment) Act (Northern Ireland) 1963 which is now repealed.

The provisions, insofar as they confer or affect powers to make regulations and orders are brought into operation on 11th December 1983 and for other purposes on 1st January 1984.
