The Department of Economic Development, in exercise of the powers conferred on it by Article 1(1) of the Companies (Northern Ireland) Order 1982(a) read with paragraph 2(1)(b) of Schedule 1 to the Northern Ireland Act 1974(b), hereby makes the following Order:

#### Citation

1. This Order may be cited as the Companies (1982 Order) (Commencement No. 1) Order (Northern Ireland) 1983.

#### Commencement

- 2.—(1) Subject to paragraph (2) all provisions of the Companies (Northern Ireland) Order 1982, shall insofar as they confer or affect any power to make regulations and orders come into operation on 11th April 1983 and shall for all other purposes come into operation on 1st July 1983.
- (2) Paragraph (1) does not apply to the provisions set out in the Schedule to the extent mentioned in that Schedule.

#### **EXPLANATORY NOTE**

(This note is not part of the Order.)

This Order brings into operation, on 11th April 1983 insofar as they confer or affect any powers to make regulations and orders and for all other purposes on 1st July 1983, all provisions of the Companies (Northern Ireland) Order 1982, except those listed in the Schedule. The provisions brought into operation relate to interpretation, company accounting and disclosure, share capital, disclosure of interests in shares, and various miscellaneous and supplemental provisions.

The Companies (Northern Ireland) Order 1982 is to be construed as one with the Companies Acts (Northern Ireland) 1960 to 1981. The functions of the Department of Commerce under those Acts were transferred to the Department of Economic Development by the Departments (No. 2) (Northern Ireland) Order 1982 (S.I. 1982/846 (N.I. 11)) Article 4, which was brought into operation by S.R. 1982 No. 221 (C. 4).
