The Foyle Fisheries Commission, in exercise of its powers under section 13(1) of the Foyle Fisheries Act 1952(a) and section 13(1) of the Foyle Fisheries Act (Northern Ireland) 1952(b) with the approval of the Minister for Fisheries and Forestry in the Republic of Ireland(c) and of the Department of Agriculture for Northern Ireland(d) hereby makes the following regulations:-

Citation and commencement

1. These regulations may be cited as the Foyle Area (Control of Netting) (Temporary Provisions) Regulations 1984, and shall come into operation on 20th June 1984.

Amendment of Foyle Area (Control of Netting) Regulations 1981

2. From 20th June 1984 to 31st August 1984 both dates inclusive the Foyle Area (Control of Netting) Regulations 1981(e) shall have effect subject to the amendments in paragraphs (1) and (2) below.

(1) For Regulation 9(b) there shall be substituted—

- "(b) no drift net shall be used for the purpose of taking or with intent to take salmon during the period commencing at 1700 hours on any day and ending at 0700 hours the next following day;".
- (2) For regulation 10(b) there shall be substituted—
 - "(b) no drift net shall be used for the purpose of taking or with intent to take salmon during the period commencing at 1700 hours on any day and ending at 0700 hours the next following day;".

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These Regulations provide for a temporary amendment of the Foyle Area (Control of Netting) Regulations 1981 which control and restrict both draft and drift netting for salmon in the Foyle Area.

They prescribe that, for the duration of the 1984 drift net fishing season, fishing by drift net is prohibited during the period between 1700 hours (5 p.m.) on any day and 0700 hours (7 a.m.) on the next following day instead of during the period between 0500 hours (5 a.m.) and 1700 hours (5 p.m.) on any day.
