The Department of the Environment in exercise of the powers conferred on it by Articles 132(2), 135 and 218(1) of the Road Traffic (Northern Ireland) Order 1981(a) and of all other powers enabling it in that behalf and with the approval of the Department of Finance and Personnel(b) makes the following regulations:

Citation and commencement

1. These regulations may be cited as the Motor Cars (Driving Instruction) (Amendment) Regulations (Northern Ireland) 1985 and shall come into operation on 24th June 1985.

Revocation

2. The Motor Cars (Driving Instruction) (Amendment) Regulations (Northern Ireland) 1976(c), the Motor Cars (Driving Instruction) (Amendment) Regulations (Northern Ireland) 1979(d) and the Motor Cars (Driving Instruction) (Amendment) Regulations (Northern Ireland) 1982(e) are revoked.

Regulation amended

3. For regulation 18 of the Motor Cars (Driving Instruction) Regulations (Northern Ireland) 1974(f) there shall be substituted—

"Fees

18.—(1) A person applying to submit himself to the written part of the examination shall pay a fee of £50.

(2) A person applying to submit himself to the practical part of the examination shall pay a fee of £90.

(3) The fee to be paid by a person who applies for the entry of his name in the Register shall be ± 100 .

(4) The fee to be paid by a person who applies for the renewal of an entry of his name in the Register for a further period of 4 years shall be £100.

(5) The fee to be paid by a person exempted under regulation 20(1) applying for the entry of his name in the Register shall be ± 100 .

(6) The fee to be paid by a person who applies for the re-entry of his name in the Register shall be £100 if that person's name has been removed from the Register and by virtue of regulation 20(3) he is not required again to pass the examination.

. EXPLANATORY NOTE

(This note is not part of the regulations.)

These regulations further amend the Motor Cars (Driving Instruction) Regulations (Northern Ireland) 1974 ("the 1974 regulations") by

(1) increasing the fees for-

- (a) the written part of the examination, from £25 to £50;
- (b) the practical part of the examination of ability to give instruction, from £60 to £90;
- (c) an application for entry in the Register following the passing of the examination, from £50 to £100;
- (d) an application for renewal in the Register, from $\pounds 60$ to $\pounds 100$;
- (e) an application for entry in the Register by a person in the corresponding Register in Great Britain, from £60 to £100;
- (f) an application for re-entry in the Register where the applicant is not required to pass the examination in the circumstances described in regulation 20(3) of the 1974 regulations, from £60 to £100; and
- (g) an application for a licence or renewal thereof to give instruction, from £45 to $\pounds 85$.
- (2) revoking three spent amending regulations to the 1974 regulations.
