The Department of the Environment in exercise of the powers conferred on it by Articles 54(1), 58(1) and 218(1) of the Road Traffic (Northern Ireland) Order 1981(a) and of all other powers enabling it in that behalf, and with the approval of the Department of Finance and Personnel(b) as regards regulation 2, hereby makes the following Regulations:

Citation and commencement

1. These Regulations may be cited as the Goods Vehicles (Certification) (Fees) (Amendment) Regulations (Northern Ireland) 1985 and shall come into operation on 2nd September 1985.

Amendment of the 1982 regulations

- 2. Regulation 8 of the Goods Vehicles (Certification) Regulations (Northern Ireland) 1982(c) shall be amended as follows:
 - (a) in column (2) of Part I of the Table for "£10.00" there shall be substituted "£10.70"; and
 - (b) in column (2) of Part II of the Table for "£5.00" there shall be substituted "£5.35".

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These Regulations further amend the Goods Vehicles (Certification) Regulations (Northern Ireland) 1982 by—

- (1) increasing the fee payable on application for a certificate for a goods vehicle (other than a trailer) not exceeding 1,525 kilograms unladen weight, from £10.00 to £10.70 (regulation 2(a));
- (2) increasing the fee payable (following a refusal of a licence) on re-application for a certificate for a goods vehicle (other than a trailer) not exceeding 1,525 kilograms unladen weight, from £10.00 to £10.70 (regulation 2(a));
- (3) increasing from £5·00 to £5·35 the fee payable where a re-application is made within 21 days from a notice of refusal and the vehicle is presented for re-inspection on a date appointed by the Department of the Environment (regulation 2(b)).
