ROAD TRAFFIC AND VEHICLES

**Urban Clearways (Belfast) (No. 2) Order (Amendment) Order
(Northern Ireland) 1985**

Made 9th September 1985

Coming into operation 27th October 1985

WHEREAS the Department of the Environment has published a notice in compliance with Article 23(1) and (2) of the Road Traffic (Northern Ireland) Order 1981(a);

AND WHEREAS no objection has been received;

NOW THEREFORE the Department in exercise of the powers conferred on it by Article 21(1) of the Road Traffic (Northern Ireland) Order 1981 and of every other power enabling it in that behalf makes the following order:—

Citation and commencement

1. This order may be cited as the Urban Clearways (Belfast) (No. 2) Order (Amendment) Order (Northern Ireland) 1985 and shall come into operation on 27th October 1985.

Amendment

2. The Urban Clearways (Belfast) (No. 2) Order (Northern Ireland) 1981(b) shall be amended as follows:—

(1) In Article 1(2)—

(a) in the definition of “carriageway” after the word “vehicles” there shall be added the words “but does not include a lay-by”;

(b) the definition of “hard shoulder” shall be deleted;

(c) for the definition of “statutory undertaker” there shall be substituted: “statutory undertaker” means persons authorised by a statutory provision to carry on a railway, canal, inland navigation, dock, harbour, gas, electricity, telecommunications, postal services or other public undertaking.

(2) Article 4(3)(c) shall be deleted.

(3) In column 1 of the Schedule the words “and the hard shoulders” shall be deleted from the item relating to the Sydenham By-Pass, Belfast.

(4) There shall be inserted in the Schedule the items specified in the Schedule to this order.

EXPLANATORY NOTE

(This note is not part of the Order.)

This order amends the Urban Clearways (Belfast) (No. 2) Order (Northern Ireland) 1981 as follows:—

1. It prohibits the waiting by vehicles on part of Annadale Embankment and part of York Street, Belfast, during the morning and evening peak traffic periods (Article 2(4)).
2. It prohibits the waiting of vehicles on a length of the Outer Ring Road, A55 Belfast at any time (Article 2(4)).
3. Some minor drafting amendments have been made.
