Police Cadets (Amendment) Regulations (Northern Ireland) 1985

Made 3rd March 1985 1st April 1985 Coming into operation

To be laid before Parliament

The Secretary of State, in pursuance of section 10 of the Police Act (Northern Ireland) 1970(a), read with section 18 of the Administrative and Financial Provisions Act (Northern Ireland) 1962(b), and after consulting, in accordance with section 34(2) of the said Act of 1970, the Police Authority for Northern Ireland and the Police Association for Northern Ireland, and after taking into consideration the recommendations made by the Police Negotiating Board for the United Kingdom and furnishing that Board with a draft of the regulations in accordance with section 2(1) of the Police Negotiating Board Act 1980(c), hereby with the concurrence of the Treasury makes the following regulations:—

Citation, commencement and effect

- 1.—(1) These regulations may be cited as the Police Cadets (Amendment) Regulations (Northern Ireland) 1985.
- (2) These regulations shall come into operation on 1st April 1985 and shall have effect for the purposes of regulation 4 as from 25th October 1984.

Interpretation

2. In these regulations any reference to the principal regulations is a reference to the Police Cadets Regulations (Northern Ireland) 1980(d).

Travel allowances

- 3.—(1) In regulation 17(1) of the principal regulations for the words "£0.50" there shall be substituted the words "£1".
- (2) In regulation 17(2) of the principal regulations for the words "£36" there shall be substituted the words "£112".

Uniform and equipment

4. In regulation 18(3) of the principal regulations for the words "£22" there shall be substituted the words "£25".

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These regulations amend the Police Cadets Regulations (Northern Ireland) 1980.

Regulation 3 increases travel allowances with effect from 1st April 1985.

Regulation 4 increases the stocking allowance for women cadets to £25 a year with effect from 25th October 1984.

Retrospective effect is authorised by section 18 of the Administrative and Financial Provisions Act (Northern Ireland) 1962.
