**Warble Fly (Treatment) Scheme (Amendment) Order  
(Northern Ireland) 1985**

*Made* . . . . . 28th March 1985  
*Coming into operation* . . . . . 6th May 1985

The Department of Agriculture, in exercise of the powers conferred on it by Article 8(1) and (2) of the Diseases of Animals (Northern Ireland) Order 1981(a) and of every other power enabling it in that behalf, having consulted with the bodies which appear to it to be substantially representative of interests concerned, with the approval of the Department of Finance and Personnel(b) hereby makes the following Order:

*Citation and commencement*

1. This Order may be cited as the Warble Fly (Treatment) Scheme (Amendment) Order (Northern Ireland) 1985 and shall come into operation on 6th May 1985.

*Amendment of the Warble Fly (Treatment) Scheme (Northern Ireland) 1976*

2. The Warble Fly (Treatment) Scheme (Northern Ireland) 1976 as contained in the Schedule to the Warble Fly (Treatment) Scheme Order (Northern Ireland) 1976(c) is hereby amended as follows:

- (1) in Article 7(d) for "65p" there shall be substituted "75p";
- (2) in Article 13(1)(b)(e) for "£75" there shall be substituted "£105".

## EXPLANATORY NOTE

*(This note is not part of the Order.)*

This Order further amends the Warble Fly (Treatment) Scheme Order (Northern Ireland) 1976 by increasing:

- (a) the fee payable by herd owners for animals treated by the Department from 65p to 75p;
- (b) the amount of compensation which may be payable by the Department in respect of an animal which aborts within 7 days after treatment from £75 to £105.
