## Foyle Area (Control of Netting) (Amendment No. 2) Regulations 1986

<i>Made</i>	13th May 1986
<i>Coming into operation</i>	20th June 1986

The Foyle Fisheries Commission, in exercise of its powers under section 13(1) of the Foyle Fisheries Act 1952(a) and section 13(1) of the Foyle Fisheries Act (Northern Ireland) 1952(b) with the approval of the Minister for Tourism, Fisheries and Forestry in the Republic of Ireland(c) and of the Department of Agriculture for Northern Ireland(d) hereby makes the following regulations:—

*Citation and commencement*

1. These regulations may be cited as the Foyle Area (Control of Netting) (Amendment No. 2) Regulations 1986 and shall come into operation on 20th June 1986.

*Amendment to the Foyle Area (Control of Netting) Regulations 1981*

2. The Foyle Area (Control of Netting) Regulations 1981(e) shall be amended as follows:—

(1) For regulation 9(b) there shall be substituted:—

“(b) no drift net shall be used for the purpose of taking or with intent to take salmon during the period commencing at 17 00 hours on any day and ending at 07 00 hours on the next following day;”;

(2) For regulation 10(b) there shall be substituted:—

“(b) no drift net shall be used for the purpose of taking or with intent to take salmon during the period commencing at 17 00 hours on any day and ending at 07 00 hours on the next following day;”.

#### EXPLANATORY NOTE

*(This note is not part of the Regulations.)*

These regulations amend the Foyle Area (Control of Netting) Regulations 1981 which control and restrict both draft and drift netting for salmon and trout in the Foyle Area.

They prohibit fishing for salmon by drift net during the period between 17 00 hours on any day and 07 00 hours on the next following day instead of during the period between 05 00 hours and 17 00 hours on any day.
