### Foyle Area (Weekly Close Time) (Amendment) Regulations 1986

13th May 1986 Made Coming into operation 20th June 1986

The Foyle Fisheries Commission, in exercise of its powers under sections 13(1) and 28(3) and (4) of the Foyle Fisheries Act 1952(a) and sections 13(1) and 27(3) and (4) of the Foyle Fisheries Act (Northern Ireland) 1952(b) with the approval of the Minister for Tourism, Fisheries and Forestry in the Republic of Ireland(c) and of the Department of Agriculture for Northern Ireland(d) hereby makes the following regulations:-

#### Citation and commencement

1. These regulations may be cited as the Foyle Area (Weekly Close Time) (Amendment) Regulations 1986 and shall come into operation on 20th June 1986.

- 2. For regulation 3(b) of the Foyle Area (Weekly Close Time) Regulations 1981(e) there shall be substituted:
  - "(b) In the River Foyle the period beginning at 18 00 hours on Friday and ending at 18 00 hours on the following Monday."

# Fisheries EXPLANATORY NOTE

(This note is not part of the Regulations.)

These Regulations amend the Foyle Area (Weekly Close Time) Regulations 1981 which prescribe the weekly close time period during which commercial fishing for salmon and trout is prohibited in specified parts of the Foyle Area. They prohibit commercial fishing for salmon and trout in one of those parts, the River Foyle, between 18 00 hours on Friday to 18 00 hours on the following Monday instead of during the period 06 00 hours on Saturday to 06 00 hours on the following Tuesday.
