The Department of Health and Social Services, in exercise of the powers conferred on it by Article 1(2) of the Health and Social Security (Northern Ireland) Order 1984(a), paragraph 2(1) of Schedule 1 to the Northern Ireland Act 1974(b) and of all other powers enabling it in that behalf, hereby makes the following order:

#### Citation

1. This order may be cited as the Health and Social Security (1984 Order) (Commencement No. 2) Order (Northern Ireland) 1986.

#### Day appointed

2. 1st July 1986 is the day appointed for the coming into operation of the following provisions of the Health and Social Security (Northern Ireland) Order 1984:

- (a) Article 3(1)(a) and (2) and Schedule 1 (optical appliances);
- (b) the repeals in Schedule 6 relating to Articles 2(2), 5(5)(c), 55(1)(d), 62(2)(e)of, Schedule 11 to, and Schedule 15 to, the Health and Personal Social Services (Northern Ireland) Order 1972(c);
- (c) Article 17 so far as it relates to the repeals mentioned in paragraph (b) of this Article.

# EXPLANATORY NOTE

## (This note is not part of the Order.)

This order appoints 1st July 1986 as the day for coming into operation of some provisions of the Health and Social Security (Northern Ireland) Order 1984. The provisions effect, or arise out of, the removal of the dispensing of optical appliances from the general ophthalmic services provided as part of the health service and the replacement of that dispensing service by a system of payments towards the cost incurred for optical appliances supplied on a prescription following a sight test under the health service.
