**The County Court Fees (Amendment) Order (Northern Ireland) 1986**

*Made* . . . . . 13th June 1986

*Coming into operation* . . . . . 1st August 1986

The Lord Chancellor, in exercise of the powers conferred on him by section 116(1) of the Judicature (Northern Ireland) Act 1978(a), after consultation with the Lord Chief Justice and with the concurrence of the Treasury, hereby makes the following Order:—

1. This Order may be cited as the County Court Fees (Amendment) Order (Northern Ireland) 1986 and shall come into operation on 1st August 1986.

2. The County Court Fees Order (Northern Ireland) 1981(b) shall be amended as follows—

- (a) by deleting, in Section I of Schedule 1, fees Nos. 7 and 11 and inserting the fees so numbered in Part 1 of the Schedule to this Order;
- (b) by inserting in Schedule 1, after Section V, the new Section VI set out in Part 2 of the Schedule to this Order.
