# Companies (Disqualification Orders) Regulations (Northern Ireland) 1986

Made..<

The Department of Economic Development, in exercise of the powers conferred on it by Articles 309(1) and 681(1) of the Companies (Northern Ireland) Order 1986(a) and of every other power enabling it in that behalf, hereby makes the following regulations:

#### Citation and commencement

1. These regulations may be cited as the Companies (Disqualification Orders) Regulations (Northern Ireland) 1986 and shall come into operation on 27th October 1986.

## Interpretation

- 2. In these regulations—
- "the Order" means the Companies (Northern Ireland) Order 1986;
- "disqualification order" means an order of the court made under any of Articles 304 to 308 of the Order;
- "grant of leave" means a grant by the court of leave to any person in relation to a disqualification order.

#### Application and revocation

- 3.—(1) These regulations apply in relation to a disqualification order made after the coming into operation of these regulations; and to a grant of leave, variation or quashing, made after that date, of a disqualification order made before, on or after that date.
- (2) The Companies (Disqualification Orders) Regulations (Northern Ireland) 1983(b) are hereby revoked.

#### Prescribed officers

- **4.**—(1) The following officers of the courts shall furnish to the Department the particulars prescribed in regulation 5(1) to (3) in the form and manner there specified—
  - (a) where a disqualification order or grant of leave is made by the High Court, the senior clerk in the Bankruptcy and Companies Office of the Supreme Court;
  - (b) where a disqualification order is made by the Crown Court, the Chief Clerk;
  - (c) where a disqualification order or grant of leave is made by a county court, the Chief Clerk; and
  - (d) where a disqualification order is made by a magistrates' court, the Clerk of Petty Sessions.

(2) Where a disqualification order made by any of the courts mentioned in paragraph (1) is subsequently varied or quashed on appeal by another court, the officer of the first-mentioned court prescribed in paragraph (1) shall furnish the Department with the particulars prescribed in regulation 5(4) in the form and manner there specified.

#### **Forms**

- 5.—(1) The form set out in Schedule 1 is the form prescribed for the purposes of Article 309(1) of the Order when the person against whom the disqualification order is made is an individual and the particulars contained therein are the particulars prescribed for that purpose.
- (2) The form set out in Schedule 2 is the form prescribed for the purposes of Article 309(1) of the Order when the person against whom the disqualification order is made is a corporation and the particulars contained therein are the particulars prescribed for that purpose.
- (3) The form set out in Schedule 3 is the form prescribed for the purposes of Article 309(1) of the Order when the court grants leave to any person in relation to a disqualification order and the particulars contained therein are the particulars prescribed for that purpose.
- (4) The form set out in Schedule 4 is the form prescribed for the purposes of Article 309(1) of the Order when a disqualification order is varied or quashed on appeal, and the particulars contained therein are the particulars prescribed for that purpose.

# Time for delivery of particulars

6. The time within which the prescribed officer is to furnish the Department with the prescribed particulars under Article 309(1) of the Order shall be a period of fourteen days beginning with the day on which the disqualification order or grant of leave is made, or the disqualification order is varied or quashed on appeal, as the case may be.

## EXPLANATORY NOTE

(This note is not part of the Regulations.)

These regulations revoke and replace the Companies (Disqualification Orders) Regulations (Northern Ireland) 1983 as a consequence of the consolidation of the Companies Acts (Northern Ireland) 1960 to 1983 by the Companies (Northern Ireland) Order 1986.

These regulations require certain court officers to provide the Department of Economic Development with particulars of disqualification orders and the granting of leave in relation to, or the variation or quashing on appeal of, such orders. They also specify the form, time and manner in which such particulars must be given.
