WHEREAS the Department of the Environment has published a notice in compliance with Article 23(1) and (2) of the Road Traffic (Northern Ireland) Order 1981(a);

AND WHEREAS two objections have been received and have been duly considered;

NOW THEREFORE the Department in exercise of the powers conferred on it by Article 21(1) of the Road Traffic (Northern Ireland) Order 1981 and of every other power enabling it in that behalf makes the following Order:—

Citation and commencement

1. This Order may be cited as the One-Way Traffic (Belfast) (Amendment No. 2) Order (Northern Ireland) 1986 and shall come into operation on 30th November 1986.

Amendment .

2. Schedule 2 to the One-Way Traffic (Belfast) Order (Northern Ireland) 1986(**b**) shall be amended by:—

- (1) the deletion therefrom of the items relating to Hope Street, Downshire Place and Little Victoria Street from its junction with Hope Street to its junction with Downshire Place;
- (2) the addition thereto of the following items:----

EXPLANATORY NOTE

(This note is not part of the Order.)

This Order amends the provisions of the One-Way Traffic (Belfast) Order (Northern Ireland) 1986.

The amendment provides for the re-introduction of two-way traffic in Downshire Place and parts of Hope Street and Little Victoria Street and for the introduction of one-way traffic on the Link Road (Inner Ring) from Charles Street South to Dublin Road and on parts of Dublin Road and Great Victoria Street.
