The Department of Health and Social Services in exercise of the powers conferred on it by Article 8 of the Health and Personal Social Services (Northern Ireland) Order 1978(a) and of every other power enabling it in that behalf, after consultations with such organisations as appeared to the Department to be representative of the medical profession, hereby makes the following regulations:

Citation, commencement and interpretation

1.—(1) These regulations may be cited as the Medical Practitioners (Vocational Training) (Amendment) Regulations (Northern Ireland) 1986 and shall come into operation on 1st August 1986.

(2) In these regulations "the principal regulations" means the Medical Practitioners (Vocational Training) Regulations (Northern Ireland) 1979(b).

Amendment to the principal regulations

2. In regulation 4(5)(a)(i) of the principal regulations for the words "immediately before 1st January 1985" there shall be substituted the words "on the 31st July last preceding the start of the training in post".

Revocations

3. The Medical Practitioners (Vocational Training) Regulations (Northern Ireland) Amendment Regulations 1981(c), the Medical Practitioners (Vocational Training) (Amendment) Regulations (Northern Ireland) 1982(d), the Medical Practitioners (Vocational Training) (Amendment) Regulations (Northern Ireland) 1983(e), and the Medical Practitioners (Vocational Training) (Amendment) Regulations (Northern Ireland) 1984(f) are hereby revoked.

EXPLANATORY NOTE

(This note is not part of the Regulations.)

Regulation 4 of the Medical Practitioners (Vocational Training) Regulations (Northern Ireland) 1979 prescribes, for the purposes of Article 8 of the Health and Personal Social Services (Northern Ireland) Order 1978, the medical experience a general practitioner must have acquired before inclusion in the Central Services Agency medical list of those undertaking to provide general medical services. These regulations amend regulation 4(5)(a)(i) by substituting for 1st January 1985 an annual date, the 31st July, by which a post may be approved as an educationally approved post for the purpose of training a practitioner in the provision of general medical services.
