Milk (Community Outgoers Scheme) (Amendment) Regulations (Northern Ireland) 1987

13th March 1987. Made Coming into operation 13th March 1987

The Department of Agriculture, being a Department designated(a) for the purposes of Section 2(2) of the European Communities Act 1972(b) in relation to the Common Agricultural Policy of the European Community, in exercise of the powers conferred on it by that section and of every other power enabling it in that behalf hereby makes the following regulations:

- 1. These regulations may be cited as the Milk (Community Outgoers Scheme) (Amendment) Regulations (Northern Ireland) 1987 and shall come into operation on 13th March 1987.
- 2. The Interpretation Act (N.I.) 1954(c) shall apply to these regulations as it applies to a measure of the Northern Ireland Assembly.
- 3. The Milk (Community Outgoers Scheme) Regulations (Northern Ireland) 1986(d) shall be amended as follows—
 - (a) In Regulation 4(1) for "2.618p" there shall be substituted "3.927p".
 - (b) In Regulation 4(3)(a) for "2.618p" there shall be substituted "3.927p".
 - (c) In Regulation 4(3)(b) for "18.326p" there shall be substituted "27·489p".
 - (d) In Regulation 6(2) for "31st January 1987" there shall be substituted "13th March 1987".
 - (e) In Regulation 12(b) for "level 5 on the standard scale" there shall be substituted "£2,000".

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These Regulations implement Commission Regulation (EEC) No. 261/87 (O.J. No. L26, 29.1.1987, p. 18) amending Commission Regulation (EEC) No. 2321/86 (O.J. L202, 25.7.1986, p. 13) as regards the submission of applications for compensation for the definitive discontinuation of milk production, and increases compensation payable under Council Regulation (EEC) No. 1336/86 (O.J. No. L119, 8.5.1986, p. 21) fixing compensation for the definitive discontinuation of milk production.

The maximum amount of compensation payable (under Regulation 4 of the principal regulations) is increased to 3.927p per litre of milk for each year of the Scheme.

The time limit (set by Regulation 6 of the principal regulations) after which an applicant may not withdraw his application is extended to 13th March 1987.

Regulation 12(b) of the above Regulations is also amended by the substitution of a figure of "£2,000" for "level 5 on the standard scale".
