The Social Security (Consolidated Fund of Northern Ireland Supplement to, and Allocation of, Contributions) (Re-rating) Order (Northern Ireland) 1987

Made 27th January 1987 6th April 1987 Coming into operation

The Department of Health and Social Services for Northern Ireland, in exercise of the powers conferred on it by sections 1(5A) and 128(4A) and (5A) of the Social Security (Northern Ireland) Act 1975(a) and of all other powers enabling it in that behalf, and with the consent of the Department of Finance and Personnel(b), hereby makes the following order:

Citation, commencement and interpretation

- 1.—(1) This order may be cited as the Social Security (Consolidated Fund of Northern Ireland Supplement to, and Allocation of, Contributions) (Re-rating) Order (Northern Ireland) 1987 and shall come into operation on 6th April 1987.
- (2) In this order "the Act" means the Social Security (Northern Ireland) Act 1975.

Alteration of Consolidated Fund of Northern Ireland supplement to contributions

2. In section 1(5) of the Act (Consolidated Fund of Northern Ireland supplement to contributions)(c) for "9 per cent." (d) there shall be substituted "7 per cent.".

Percentage rates of appropriate health service and employment protection allocations

3.—(1) Section 128(4) of the Act (allocation of contributions)(e) shall be amended in accordance with paragraphs (2) and (3) of this Article.

- (2) In the definition of "the appropriate health service allocation"—
- (a) in paragraph (a) (primary Class 1 contributions) for "0.75 per cent."; (a) there shall be substituted "0.85 per cent.";
- (b) in paragraph (b) (secondary Class 1 contributions) for "0.6 per cent." there shall be substituted "0.7 per cent.";
- (c) in paragraph (c) (Class 2 contributions) for "11.5 per cent." (b) there shall be substituted "15.5 per cent.";
- (d) in paragraph (d) (Class 3 contributions) for "11.5 per cent." (b) there shall be substituted "15.5 per cent.";
- (e) in paragraph (e) (Class 4 contributions) for "0.95 per cent." (a) there shall be substituted "1.15 per cent.".
- (3) In the definition of "the appropriate employment protection allocation"---
 - (a) in paragraph (i) (primary Class 1 contributions) for "0.25 per cent."(c) there shall be substituted "0.07 per cent.";
 - (b) in paragraph (ii) (secondary Class 1 contributions) for "0.2 per cent." there shall be substituted "0.06 per cent.".

EXPLANATORY NOTE

(This note is not part of the Order.)

This order decreases the Consolidated Fund of Northern Ireland supplement to contributions paid under the Social Security (Northern Ireland) Act 1975 from 9 per cent. to 7 per cent. (Article 2). It increases the percentage rates of the appropriate health service allocation and reduces the percentage rates of the appropriate employment protection allocation (Article 3).

Section 128(5A) of the Social Security (Northern Ireland) Act 1975, one of the enabling provisions under which this order is made, was inserted by Article 75(1) of the Social Security (Northern Ireland) Order 1986 and brought into operation on 19th November 1986 by virtue of Article 1(7) of that Order.
