**Foyle Area (Control of Netting) (Amendment No. 2)
Regulations 1987**

Made 4th June 1987

Coming into operation 22nd June 1987

The Foyle Fisheries Commission, in exercise of its powers under section 13(1) of the Foyle Fisheries Act 1952(a) and section 13(1) of the Foyle Fisheries Act (Northern Ireland) 1952(b) with the approval of the Minister for the Marine in the Republic of Ireland(c) and of the Department of Agriculture for Northern Ireland(d) hereby makes the following Regulations:—

Citation and commencement

1. These Regulations may be cited as the Foyle Area (Control of Netting) (Amendment No. 2) Regulations 1987 and shall come into operation on 22nd June 1987.

Amendment to the Foyle Area (Control of Netting) (Amendment) Regulations 1983

2. The Foyle Area (Control of Netting) (Amendment) Regulations 1983(e) shall be amended as follows:—

In Regulation 1(c) for “1st June 1987” there shall be substituted “1st September 1987”.

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These Regulations amend the Foyle Area (Control of Netting) (Amendment) Regulations 1983 to delay further the coming into operation of additional restrictions on the materials which may be used in the construction of commercial fishing nets for the capture of salmon and trout. The Foyle Area (Control of Netting) (Amendment) Regulations 1985 delayed the coming into operation of these additional restrictions from 1st June 1985 until 1st June 1986. The Foyle Area (Control of Netting) (Amendment) Regulation 1986 further delayed the coming into operation of these additional restrictions from 1st June 1986 until 1st June 1987. These Regulations delay the introduction of the additional restrictions for a further three months from 1st June 1987 until 1st September 1987.

The effect of this delay will be that a ban on two types of net in common use, namely, a multistrand monofilament and single throw monopy which is also known as super nylon or Japanese netting, will take effect from 1st September 1987 instead of 1st June 1987.

The Foyle Area (Control of Netting) (Amendment) Regulations 1983 amend the Foyle Area (Control of Netting) Regulations 1981 which control and restrict netting for salmon and trout in the Foyle Area.
