# Salaries (Parliamentary Commissioner and Commissioner for Complaints) Order (Northern Ireland) 1987

Made . . . . . 9th September 1987

Coming into operation . . 21st October 1987

To be laid before Parliament under paragraph 3(3) of Schedule 1 to the Northern Ireland Act 1974

In exercise of the powers conferred by Article 4(2) of the Salaries (Comptroller and Auditor General and Others) (Northern Ireland) Order 1973(a) and now vested in me(b) and of all other powers enabling me in that behalf, I hereby make the following Order:

#### Title and commencement

1. This Order may be cited as the Salaries (Parliamentary Commissioner and Commissioner for Complaints) Order (Northern Ireland) 1987 and shall come into operation on 21st October 1987.

#### Revocation

2. The Salaries (Comptroller and Auditor General and Others) Order (Northern Ireland) 1987(c) is hereby revoked insofar as it remains in force.

#### Increases in salaries

3. The annual salary payable to the Parliamentary Commissioner and the Commissioner for Complaints shall be increased from 1st April 1987 from £38,425 to £40,058 and from 1st October 1987 from £40,058 to £41,000.

#### **EXPLANATORY NOTE**

(This note is not part of the Order.)

This Order provides for increases in the annual salaries payable to the Northern Ireland Parliamentary Commissioner for Administration and the Northern Ireland Commissioner for Complaints following recommendations made in the Report of the Review Body on Top Salaries in 1987 (HMSO CM 128).

Article 2 revokes the Salaries (Comptroller and Auditor General and Others) Order (Northern Ireland) 1987 insofar as it remains in force. That Order ceased on 1st April 1987 to have effect in relation to the salary of the Comptroller and Auditor General which is now determined in accordance with the provisions of the Audit (Northern Ireland) Order 1987.

This Order is made with retrospective effect by virtue of Article 4(2) of the Salaries (Comptroller and Auditor General and Others) (Northern Ireland) Order 1973.
